OiMP MEMBER CODE OF CONDUCT

As a member in good standing of the Ontario Independent Meat Processors Association, I subscribe to the "Code of Conduct" as a condition of membership.

OiMP Mission Statement: To support and foster a safe and wholesome meat and poultry industry, maintaining viability and high quality through ongoing education, research, and representation at all levels of Government.

OiMP Goals and Objectives: Promote safe production of meat products with a qualified trained workforce; Create access to funding opportunities; Enhance the image of the meat and poultry industry; Improve consumer confidence through education; and Build a strong membership base.

OiMP Member Code of Ethics: Members shall promote and foster fair trade practices in the best interests of consumers, members, suppliers, and the meat processing industry; Members shall maintain high food safety standards to fully protect product safety, quality, and integrity; Members shall comply with municipal, provincial, and federal regulations and standards, as applicable to the goods and services they offer; and Members shall emphasize animal welfare and shall provide humane treatment for livestock and poultry during transport, holding, and slaughter. Employees involved with animals will be expected to practice humane handling techniques.

OiMP Membership Termination: Under Section 6.4 of the OiMP Constitution, membership in the Association may be suspended or cancelled by the Board: At the request in writing of the member; If conduct of the member is deemed by the Board to be detrimental to the interests of the Association; When a member fails to be current with membership dues; or A member declares bankruptcy.

An aggrieved member shall have the right of appeal to the Board of Directors in accordance with the Statutory Powers Procedures Act 1971.
